A. JOINING FEE

\$226 one off charge on joining

SUMMARY OF PROCESS

A full description of the fee structure and billing process is contained in the Registered Party (RP) Deed. If there are any inconsistencies between the details provided in this document and the RP Deed, the provisions of this document shall prevail.

A. JOINING

The joining fee is invoiced when the Registered Party (RP) signs a contract with NGR for access into the system. This contract is for a minimum of 12 months.

On completion of 12 months, the RP may elect to depart the system by providing written notice of this intention, 30 days prior to the expiration of the term.

The RP is issued with a security ID and password for access into the secure area of the web system.

B. LISTING

1. On signing the contract, the RP advises NGR of the estimated number of listings.
2. The RP is billed in advance if the total listing level is 350 or less or monthly if the number of estimated listings is more than 350.
3. The listing levels are reconciled in May/June each year using figures for listings provided by the RP and listing numbers from within the NGR system. Reference may be made to Bulk Handlers' records to assist in this determination.

4. The RP is issued a reconciliation invoice as an adjustment between projected and actual listing levels
5. Charging for the next 12 months is based on the RP's previous history.
6. The RP may delist up to a maximum of 20% of listings in April of each year.

C. SERVICE REQUESTS

NGR will provide an after-hours service for any communications problems that occur. An after-hours call-out is chargeable to the RP, After hours is defined as:

1. Outside Call Centre Hours (as published on the Web Site)

The charge rate is actual labour costs (including on-costs) plus 10%.

D. CONVERSION OF RP NUMBERS

RP's will be provided with an option of a bulk conversion process for data files. This will provide a matching NGR number for all records provided which have an existing ABB, AusBulk, AWB or Grainco Australia number that can be matched to stored data within the system.

This bulk conversion will be charged either at a flat rate of \$3,000 per conversion process or \$1.00 per match, whichever is the higher amount.

E. EXCESSIVE ACCESS FEE

Excessive enquiries, downloads or calls to the call centre may cause slowing of the system and disrupt normal system processing. "Excessive" access will be monitored and an initial warning will be given. However, continued excessive access will be charged at a fee determined by NGR Pty Ltd.

F. PENALTY INTEREST

Accounts are issued as tax invoices and are payable within 14 days of receipt. Accounts over 14 days from date of receipt will be charged interest at a rate of 3% above the Commonwealth Bank of Australia corporate overdraft rate.
