eDOCS streamlines the process of completing industry forms for the delivery of grain between growers, traders and end-users. Making industry documents that meet compliance regulations more accessible and easier to complete for both growers and traders, eliminating errors and limiting risk.

SUSTAINABILITY DECLARATION

ISCC with Sustainable Grain Australia. This single electronic Sustainability Declaration to suit the ISCC requirements for International Trade of Sustainable commodities, has streamlined the process for the grower, by only requiring the completion of one form for the various traders they deal with.

HARVEST DECLARATION

Combined Harvest Declaration (HD) project with Royalty Managers to collect data in a streamlined process on behalf of Royalty Managers (Seed Breeders). This option has over a 75% return rate and means Growers don't have to complete multiple forms when advising of their Harvest information.

COMMODITY DECLARATION

The end-to-end Commodity Vendor Declaration (CVD) form is a single input declaration that is digitally transferred from a grower, via a trader and on to the end user. By using the digital CVD within myNGR, it limits the duplication and risk of error in passing physical documentation through this multi-touchpoint process of trades.

WITH GROWER CONSENT

A Grower must provide a Data Subscriber with their NGR Card Number in order to have access to shared information.

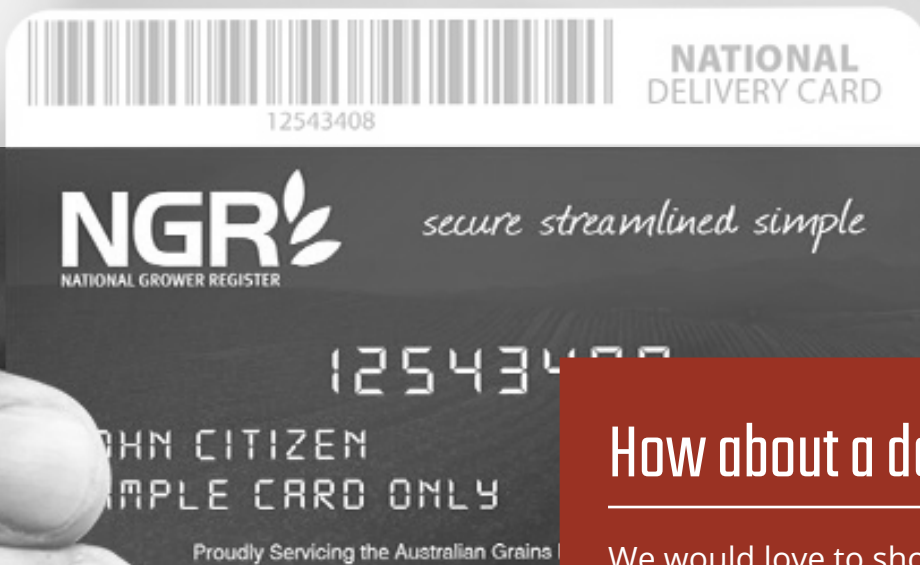
